CONDITIONS OF HIRE

The following information outlines the terms and conditions for camping equipment hire, please take the time to read them thoroughly and initial and sign where requested.

PLEASE RESPECT AND LOOK AFTER THE EQUIPMENT YOU HIRE AS IF IT WAS YOUR OWN.

SMOKING IS NOT PERMITTED IN THE TENTS.

☐ The hirer or prospective hirer (person hiring or intending to hire the equipment) by accepting to make a booking to hire the equipment enters into an agreement with *Aussie Camping Hire* whereby the hirer or prospective hirer agrees to the terms and conditions of hire as described below. Amounts outlined throughout this agreement are in Australian Dollars (\$AUD).

☐ All hirers must agree to pay a Security Bond (if requested) - ***Aussie Camping Hire accepts payments in Cash, Direct Deposit (EFT) or via Paypal (Paypal charges will be levied upon any funds paid this way).*** The Security Bond will be refunded (via bank deposit) to the hirer within 7 working days after the item/s is returned unless loss or damage has occurred in which case it will be held until all costs are finalised and deducted from the bond money. An imprint of a MasterCard/Visa Card is required prior to all bookings. Any additional costs that need to be recovered will be charged against the hirer's credit card.

INITIAL:-

☐ A 20% deposit fee is required (if requested), once a booking has been made. The payment terms for this deposit is typically 48 hours, *Aussie Camping Hire* reserves the right to cancel bookings for the hire equipment if the deposit payment is not received within the specified 48 hours. The balance of the payment must be received no later than 7 days prior to hire date or as agreed.

INITIAL:-

☐ If the equipment is returned damaged or inoperable the hirer agrees to pay *Aussie Camping Hire* the reasonable cost of the repair, or replacement in the event that an item is not repairable or not cost effective to repair. If damages exceed the bond monies then additional charges will be incurred. The Hirer will pay the outstanding monies via Direct Deposit the balance owing within 7 days. Should recovery of outstanding monies be warranted, all cost incurred recovering said monies (such as court costs, legal fees, debt collectors, interest accrued etc.), will be at the expense of the Hirer. If the equipment/s is deemed unrepairable then full retail value of the item/s will be charged. No cooking equipment is to be used inside any tents (if supplied). All equipment must be returned cleaned and well maintained. **Cleaning of dirty equipment will be deducted from the Security Bond (a cleaning charge of \$70.00 will be levied if portable toilets are returned still containing human waste).**

INITIAL:

☐ All equipment must be returned on the due date (unless prior arrangements have been made during the hire period). Failure to adhere to this condition will incur a penalty payment of 3 (three) times the 1 day hire rate for each day the equipment is late in being returned.

In the event that the equipment is not returned by the due date (or a date as having been allowed via an arrangement in writing during the hire period) the owner shall be entitled to apply to wait a court of competent jurisdiction in any state or Territory of Australia or to a Federal Court of the Commonwealth of Australia for an order requiring the return of all equipment or allowing the recapturing of the equipment and the hirer/s shall hearing agreed to pay the owner's legal costs on an indemnity basis associated with recovering the equipment and any economic loss incurred.

INITIAL:

☐ There are no refunds, partial or otherwise, and no future credit accrued as a result of early return of the hire equipment.

INITIAL:

☐ *Aussie Camping Hire* will not be held responsible for any costs or inconvenience resulting from the breakdown or failure of hire equipment. All effort is made to ensure equipment is clean and well maintained.

INITIAL:

☐ The hirer and all parties using any of the hire items whether with or without the express permission of the hirer, understands and agrees that *Aussie Camping Hire* and any related parties are not liable for any costs or damages incurred by the hirer or any other such party as a result of theft of or from any of our equipment during the period of hire or due to breakdown of the hire equipment. This includes but is not limited to costs such as accommodation, meals, flights, car hire, phone calls or any other costs incurred.

The hirer and all parties using any of the hire items whether with or without the express permission of the hirer, also indemnifies *Aussie Camping Hire* and any related parties with respect to any and all costs, damages or injuries (including such damages and injuries to third parties) incurred through the use, misuse or accident arising from the use or misuse of any of the hire products whether by negligence of *Aussie Camping Hire* or otherwise.

Aussie Camping Hire gives no express or implied warranty as to any matter whatsoever including without limitation the condition of the equipment merchantability or fitness for any particular purpose or use.

The hirer and all parties using any of the hire items whether with or without the express permission of the hirer, also indemnifies *Aussie Camping Hire* and any related parties with respect any and all costs, damages or injuries incurred through items left in the hire equipment which are received, handled or stored by *Aussie Camping Hire* before, during or after the hire period whether by negligence or otherwise.
